

Terms and Conditions:

- 1) A Nursery grower should have a minimum land holding of (04) kanals with no ceiling on furtherups.
- 2) Any Nursery grower who intends to register more than 01 nursery must have minimum 04 kanals of land for each nursery.
- 3) A nursery grower shall mandatorily prepare a lay out plan of the nursery and install sign board at a specific place depicting the complete record of fruit plants raised in the nursery with regard to scion/root stock etc.
- 4) A nursery grower shall have to maintain and label the fruit plants as per variety and pedigree record of scion/root stock used for propagation along with other related information and should be put to display at a particular place for checking of the designated departmental officers.
- 5) All such fruit plant nurseries are required to be demarcated by the revenue authority depicting their title / land holding etc.
- 6) All other requirements covered under the established guidelines of Nursery Registration Act shall be strictly followed.

Subject:- Public Notice.

Ref:- This Office letter No. Dev/NRO/19-20/144-80 dated:-19-06-2019

With reference to the subject cited above, it is hereby notified for general Public and Nursery Growers in particular that the following points are inserted in "Terms and Conditions" of the said Notice at S.No. 7-11 as under

Terms and Conditions

7. The registration of a particular Nursery shall be valid for a period of two years in first instance.
8. The licensee shall make an application for renewal of licence which shall be in Form IV. The application should reach the competent authority within a period of one month from the date of expiry of license.
9. After considering the report of Inspecting Officer, the competent authority shall renew the license granted under Section V of the act for one Calendar Year on payment of the Renewal fee prescribed in rule V.
10. If for some reason, a Nursery Grower leaves a gap of even 01 year in getting the license renewed, he will have to apply for a fresh registrations.
11. If a grower changes site/ land of Nursery before the scheduled limit of 02 years. He will have to apply for a fresh registration.

Note:- Due to addendum, the system requires 5-6 days for updating, hence the window shall be thrown open for registration w.e.f 01-07-2019.
